This special meeting has been called to review, assess and pass the new proposed amendments in the Constitution of the Association. The proposed amendments have been thoroughly discussed in the Executive Committee and are now recommended to the General Body to be adopted and passed.

Friends, since long it has been felt that we must assess and re-evaluate ourselves to cope with the fast changing scenario of the Indian and International film and television industry. We have to update the ways of working of the Association to face the new challenges of the media and entertainment industry.

This involved documenting and double-checking the validity of all the proposals to amend clauses therein, doing independent research by scouring through the different relevant laws. It took months of the time and effort of Executive Committee in general and the Constitution Amendment Sub-Committee in particular.

We are enclosing/attaching herewith the clauses of the 2016 Constitution, which are to be amended along with the proposed 2019 amendments.

If you have any suggestion regarding these amendments/or new amendments please send them to the office of the Association by 27<sup>th</sup> July 2019 on or before 5.00 p.m. Failing which the member's suggestion and proposal will not be entertained in the Special General Body Meeting.


