- 3) TO STAND FOR ELECTION FOR AN OFFICE BEARER'S POST, A MEMBER WILL HAVE TO HAVE SERVED AT LEAST ONE FULL TERM AS AN ORDINARY MEMBER OF THE EXECUTIVE COMMITTEE.
